## **CERTIFICATION OF REPRESENTATIVE**

Pursuant to Section 2422.5 of the Rules and Regulations of the Federal Labor Relations Authority (the Regulations), a petition was filed by the International Association of Machinists & Aerospace Workers, AFL-CIO, Local Lodge 2297 (the Petitioner) pursuant to section 7111(b) of the Federal Service Labor-Management Relations Statute (the Statute). The petition sought to clarify that the Department of Defense, Defense Logistics Agency, Defense Supply Center Richmond, Virginia (the Gaining Agency), as a result of a reorganization, was a successor employer to certain employees performing supply, storage and distribution (SS&D) functions for the Department of the Navy, Fleet & Industrial Supply Center, Cherry Point Detachment, Cherry Point, North Carolina (the Losing Agency). Prior to the reorganization, the Petitioner represented an appropriate unit of SS&D employees at the Losing Agency.

The American Federation of Government Employee, AFL-CIO represents a consolidated unit of employees at various other facilities of the Gaining Agency.

A hearing was held before a Hearing Officer of the Authority on January 14 and 15, 2009. Based on the hearing record, I issued a Decision & Order on August 28, 2009. Because no timely application for review of this Decision and Order was filed with the Authority that decision is now final and the petition is granted on grounds that Petitioner represents a majority of employees in a separate unit of non-professional SS&D employees, which remains appropriate, and the Gaining Agency is a successor employer of the employees in that unit.

Accordingly, I hereby certify the unit represented by the **International Association of Machinists & Aerospace Workers, AFL-CIO, Local Lodge 2297**, as originally certified in Case No. WA-RP-04-0006, as follows:
